1. A minimum of 500 gallons must be purchased. Any gallons over 2000 would need manager approval.
2. Early pre-buy price of \$2.049 per gallon is available from April 1st, 2025 - April 30th, 2025 only.
3. **A signed contract must be received with payment on or before April 30th, 2025.** _____

6. **The pre-buy price is a fixed price per gallon and does not change until your gallons are exhausted, or the 2025-2026 contract expires, whichever occurs first.** The pre-buy gallons must be used FIRST, regardless of current market price. Any gallons delivered beyond your contracted gallons will be invoiced at the current market price. **Glider Oil Company, Inc. is not responsible for any shortage or overage of gallons purchased.** _____

7. Automatic delivery will resume even after contract gallons are exhausted unless customer calls to change account to will call. _____

8. If you wish to cancel the pre-buy agreement; there is a \$150.00 cancellation fee and a restocking fee of .10¢ per gallon for any unused Pre-buy gallons. _____

9. Any credit balance on accounts after May 31, 2026 from unused pre-buy gallons will remain on your account and can be used against future deliveries at the current market price or to purchase a future Pre-buy.

10. Pre-buy credits cannot be transferred to another account. Pre-buy gallons can only be delivered to the established ship to address.

11. Heating Assistance HEAP Funds are **NOT** eligible to be used towards a pre-buy.
