**2021-2022 Will Call Delivery Pre-Buy Contract for Propane**

1. A minimum of 500 gallons must be purchased. A maximum pre-buy purchase of 2000 gallons is allowed. Any gallons over the 2000 would need approval. A minimum delivery of 125 gallons is required. **Additional fees apply for same day, out of route, or weekend deliveries.**

2. A Pre-buy price of \$1.799 per gallon runs from July 1<sup>st</sup>, 2021 thru July 31<sup>st</sup>, 2021 only. **A signed contract must be received with payment on or before July 31<sup>st</sup>, 2021.**

A SECOND Pre-buy will be offered after August 1<sup>st</sup>, 2021 thru September 30<sup>th</sup>, 2021. The price has not yet been determined but will not exceed \$2.349. Please call the office after July 31<sup>st</sup> to get the current Pre-buy pricing.

3. All Pre-buy offers expire on the said date; **no exception**. Your contract begins from the date payment is received. If you live in a county where propane heat is subject to sales tax, you must add the sales tax per gallon amount to the pre-buy price.

4. The Pre-buy price is a fixed price per gallon and does not change until your gallons are exhausted, or the expiration date of May 31, 2022, whichever occurs first. The pre-buy gallons must be used FIRST, regardless of current market price. Any gallons delivered beyond your contracted gallons will be invoiced at the current market price. **Glider Oil Company, Inc. is not responsible for any shortage or overage of gallons purchased.**

5. If you wish to cancel the pre-buy agreement, there will be a \$100.00 cancellation fee. This fee will be charged to your account.

6. Any credit balance on accounts after May 31, 2022 from unused pre-buy gallons will remain on your account and can be used against future deliveries at the current market price or to purchase a future Pre-buy.

7. Pre-buy gallons can only be delivered to the established ship to address. Pre-buy credits cannot be transferred to another account.

8. Pre-buy offers CANNOT be combined with a Budget Plan or any Assistance programs. Previous years HEAP credit cannot be used for the Pre-buy offer. Heating Assistance Funds are **NOT** eligible.

**PERC TAX** – Propane Education and Research Council (the council is authorized by federal law to collect a fee on every gallon of propane sold to fund programs to enhance safety, training research and development, and consumer education.)  
This is a tax paid by all with no exemptions.

For the July Pre-buy ONLY, we are allowing you to spread your payments over two months. To qualify for payments, see below:

- 60% payment with your signed contract no later than 7/31/21
- 40% or remaining balance is owed by 8/31/21
- If you choose this option, your Pre-buy will NOT be active until 9/1/2021 assuming the pre-buy is paid in full
- Deliveries will not be available until after 9/1/21 assuming paid in full
